Registration, Tuition, and Fees

Registration fee (nonrefundable): \$200 for new enrollment. \$150 for each additional sibling.
Annual materials fee: \$300 Infants, Pre-primary, and Primary \$400 Elementary I & II \$500 Secondary
Annual Uniform Fee: \$500 (5 Shirts, 2 Long pants, 2 Shorts, Sweatshirt, P.E. Shirt)

Upon acceptance of enrollment, parents agree to a 10 month academic year commitment and are responsible for the entire tuition regardless of voluntary withdrawal. Tuition will be due for the full month if expulsion or termination is initiated by MGRI, and any prepaid tuition beyond that month will be refunded. Note that tuition applies to maintain your child's enrollment regardless of attendance or absences, whether due to illness, vacation, or holidays. Tuition, registration, and materials fees are not refundable. Tuition categories are guided by chronological age but determined by developmental characteristics. Tuition will be adjusted for a child that transitions into a different category.

A tuition discount of 5% will apply to the oldest sibling; 5% will apply for each next oldest subsequent sibling. Full materials fees apply to each sibling. Five month and ten month tuition payments will be discounted.

Payment is accepted by cash, credit card, direct bank deposit, or check. Tuition is due in full the first business day of each month and a late fee of \$50 will apply beginning the fifth business day. There will

be an additional late charge of \$50 for each week of nonpayment; a child will be considered withdrawn after a month of nonpayment. Weekly tuition payments are due the Friday prior to the week of care needed with no grace period; a late fee of \$10 per day will apply. A returned check will be charged \$50

The registration fee will be applied upon initial enrollment and will not be charged again if your child maintains continuous enrollment. The materials fee is charged for the school year of each individual child and is used for textbook rentals and curriculum enrichment.

Tuition includes expanded curriculum experiences including food activities, gardening, yoga, movement, art, and music. Materials fees include maintenance of the curriculum environment and regular consumables.

A child's arrival and departure are according to the scheduled hours. Additional fees will apply to early arrival and/or late pick-up. Note that admitting your child early is dependent on adequate teacher coverage. Late arrivals

Children wear uniforms daily and sun hats during sunny days. Snacks are served daily and are considered part of the curriculum, inviting the child's participation. Our food experiences promote healthy eating habits and choices.

VPK Wrap tuition is for any student who is currently enrolled in VPK. Wrap is considered any duration of time outside of the VPK hours of 8:30am-11:30am. For any day that VPK is not in session the regular tuition applies.

Please notify the administration a minimum of two weeks in advance of withdrawing your child. Late arrivals and absences will accrue as tardiness which may affect funding and/or academic advancement.

Note that payments are eligible for Federal Child and Dependent Care Tax Credit (CDCTC).
